STUDENT TRANSPORTATION AGREEMENT

USE OF LATE BUS SERVICE

1. Next Stop School Busing provides the service of arranging a dedicated 'late' school bus for students participating in the Arts, team sports, clubs, team practices and extra help after school.
2. Students are dropped off at general and pre-determined locations on an assigned bus route.
3. Students must carry their bus cards at all times when boarding a bus. A driver may request a card at any time and deny boarding if it is not produced. If the student lends the bus card to another person to use, or brings a non-registered student on a bus, the student will lose riding privileges for a period of one week.
4. The Student must exercise common sense and courtesy, and abide by all safety rules, while aboard a bus or in close proximity to a bus. Next Stop School Busing may establish rules of conduct for registered students. The decision of the driver on acceptable conduct on or in the vicinity of a bus, or whether the student will be denied boarding or removed from a bus on any occasion, will be final, and is not the decision of Next Stop School Busing. Next Stop School Busing may permanently deny boarding for continued or serious misconduct or repeated breach of rules. No compensation or refund will be provided if the student is denied boarding or removed from a bus.
5. Next Stop School Busing contracts with a licensed carrier to operate the bus service and is not itself the carrier. Consequently, Next Stop School Busing accepts no liability for, and by accepting this agreement the student and the Parent/Custodian agree to and hereby release and discharge Next Stop School Busing from and against, all claims, actions, injury, damages and losses, that directly or indirectly arise or are incurred by the student and the Parent/Custodian out of or are related to the use of the bus service or the non-availability of the bus service, regardless of the circumstances.
6. Student and Parent/Custodian acknowledge and accept that buses may be delayed, or cancelled, due to weather, school closures, mechanical breakdown, and other reasons beyond the reasonable control of Next Stop School Busing or the carrier, and no refunds or compensation will be payable.

REGISTRATION AND FINANCIAL TERMS

7. The registration of the student is for a **single semester**, for the school and on the route set out on the Registration form.
8. Lost bus cards - \$10 charge. HST is included in all charges. Visa or Master Card payments will be charged an additional 2%.
9. This is the entire agreement respecting the service; there are no terms, conditions, representations or warranties except as contained in this agreement; and this agreement supersedes all prior agreements. This agreement is not assignable by the student or Parent/Guardian.
10. Routes and cost are determined based on ridership. If the minimum amount of riders required is not achieved, the price may increase or the service may be cancelled.
